

Note: As per Government decision dated 3.11.2018 while finalizing the permissibility of the posts, it is brought to your notice that the said permissible posts are not final as the review of the posts has not been finalized.

- The work load of the present has been sanctioned by taking into account the number of students enrolled in the aided faculties/ departments/ subjects functioning in the college.
- It is mandatory to post in the actual college in the faculties/units/subjects mentioned in the proposal submitted by the college for appointment and the number of students certified by the university.
- Mandatory number of students for grant and maximum number of students for workload calculation should be taken into consideration.
 - A bench strength of the number of students permitted as per government rules will be mandatory for the demonstration.
- The hours prescribed for training/demonstrations/tutorials, project work must be as per the rules prescribed by the government.
 - As per the posts sanctioned to the college, reservation posts are sanctioned through the prescribed authority as per the prevailing reservation policy of the government.

Must be certified.

- Number of posts admissible in the next academic year in case of reduction in the number of students or reduction in the workload of the aided department due to other reasons I will be done.
- As per the prevailing policy of the Government no recruitment shall be made without prior permission of the Government. If any irregularity is found in the appointments in such posting posts, the said matter will be considered in the demonstration of grant. The management and the college will be responsible for the irregular appointments.
- The posts are sanctioned based on gross eligible workload of the college. For recruitment to vacant posts if it is necessary to independently submit a proposal and obtain a sanction certificate as per the prevailing policy and procedure of the Government.
