The said orders are being issued subject to the following terms and conditions.

- 1) Within 8 days from the receipt of the said appointment order, you should immediately appear at the place of appointment and submit the joining report. If you do not appear within this period, your appointment will be considered as your unwillingness to join the post.
- 2) You have to submit Medical Examination Certificate, Previous Character Certificate, Caste Validity Certificate from Competent Authority within 6 months from the date of joining. Failure to resolve the above matters will result in immediate termination of your appointment.
