Placement Cell

Along with the academic and administrative processes in a college, Career and Counseling Cell has to be a dispensation of well-informed and interested teachers. There may be a team of teachers with different subjects and interests to create a homogeneous group to translate this vision and carry out its healthy functions as an institutional imperative.

The guidance and counseling cell in a college is a resource centre of information, guidance and counseling with free accessibility and internet based global connectivity and exchange of information on professional placements.

This Cell is actively working in the college since 2009-10 in the light of same commitment. As per the orders of Hon'ble Principal, Shri Ulhas Bramhe (Director, Physical Education) worked as first co-ordinator of the cell. Shri A.S.Purohit and Shri B.S.Ingle, Shri. S. S. Malshikhre, Shri.N. R. Chaudhari worked as members. In the first three years, Campus Interview of Involute Gear Company, Pune, Intelent Global services pvt. Ltd. Aurangabad and Pharma Qurex Products Jalagon, were arranged. In those, 19 final year students were selected by those companies.

I (Dr.A.S.Purohit,, Prof. Commerce) was given the post of Co-ordinator by Hon'ble Principal in the academic year 2012-13, and the till 2016-17.. The Career Counseling and Placement Cell was very active till then, consistently working to achieve the aim.






